APPLICATION FORM

1- SCOPE OF THE RIGHT TO APPLY

The Law on the Protection of Personal Data No. 6698 ("KVKK") grants individuals defined as data subjects ("hereinafter referred to as the "Applicant") certain rights to make requests regarding the processing of their personal data, as stipulated in Article 11 of the KVKK.

The rights of the Data Subject are as follows:

a. To learn whether their personal data is being processed or not,

b. If their personal data has been processed, to request information regarding this processing,

c. To learn the purpose of the processing of their personal data and whether they are being used in accordance with this purpose,

d. To learn the third parties to whom their personal data has been transferred domestically or internationally,

e. If their personal data is incomplete or inaccurately processed, to request correction of such data and to request notification of the correction made to third parties to whom the personal data has been transferred,

f. Despite being processed in compliance with the KVKK and other relevant laws, if the reasons requiring processing cease to exist, to request deletion, destruction, or anonymization of their personal data, and to request notification of such actions to third parties to whom the personal data has been transferred,

g. To object to the occurrence of a result against them due to the exclusive analysis of their processed data through automated systems,

h. In case their personal data is processed unlawfully and causes them damages, to request compensation for the damage suffered.

2- APPLICATION METHOD

In accordance with the first paragraph of Article 13 of the KVKK; applications regarding these rights to the Data Controller, Likecard.com, must be submitted to us through the following application methods or through other methods determined by the Personal Data Protection Board ("Board"). Applications to Likecard.com "in writing" will be made by taking the output of this form and using one of the methods listed in the table. There is no need to take the output of this form for applications made via email. The Data Subject should pay attention to the following explanations in written applications.
